JCP 2.7 & 2.8



- >Transparency details should be provided on Community Tab
- Log in to jcp.org
- Go to your JSR page
- Click on 'Community' tab
- Edit the page



2.8 requirement: EG communications

- JCP 2.8 JSRs are required to provide a mechanism for the public to read all substantive discussions of the Expert Group.
- Examples: mailing lists, blogs, wikis, discussion boards
- How does the public view the EG communications?
- What are the Terms of Use of the mechanism?



2.8 requirement: EG nominations

- JCP 2.8 JSRs are required to provide the details of all Expert Group nominations via the EG communications channel.
- Names of all nominees
- Substantive deliberations/discussion of nominees
- Decision on each nominee



2.8 requirement: EG documents

- JCP 2.8 JSRs are required to provide a publicly-accessible archive of all working documents (meeting agendas, meeting minutes, draft documents, etc).
- How does the public access this archive?
- If separate from the EG communication channel, what are the Terms of Use?



2.8 requirement: comm channel

- JCP 2.8 JSRs are required to provide a mechanism for the public to provide feedback on the JSR as well as on the EG communications, EG nominations, and EG documents.
- How does the public provide feedback?
- How does the public access the archive of such feedback?
- If separate from the previous items, what are the Terms of Use?

2.8 requirement: Issue Tracker

- JCP 2.8 JSRs are required to provide a publicly readable Issue Tracker. Either the public can log issues directly into the tracker, or their requests are entered on their behalf (with a publicly readable audit trail of all comments and issues).
- How does the public access the Issue Tracker?
- How does the public request items to be logged in the Tracker?
- If separate from the previous items, what are the Terms of Use?
- Issue list is provided to the PMO with each milestone submission. This shows the disposition of all issues logged against the JSR: open, deferred, closed, and the reason for any changes.
