Meeting attendance penalties

- "Missing five meetings in a row, or missing more than twothirds of all meetings in any consecutive twelve-month period, results in loss of EC membership." (Standing Rules.)
- Since the Standing Rules went into effect in October there have been seven EC meetings: in November, January, February, March, April, May, and June.
- Samsung and SK Telecom each attended only one of these meetings (see <u>attendance record</u>.)
- They must therefore attend all of the next three meetings (July, September, October) or they will have missed two-thirds of the meetings (7 out of 10) in 12 months.
- They have each been warned about this.

JSR 355 update

- The Final Approval Ballot starts today. Please vote.
- Implementation plan 2012:
 - Oracle and IBM's duplicate seats will be eliminated for the October 2012 election.
 - All candidates will be informed that they will serve only one year.
 - The ECs will be merged immediately after the election.
- Implementation plan 2013:
 - Three ratified and two elected seats will be eliminated.
 - All remaining seats will be up for re-election.
 - Members will serve for two rather than three years thereafter.


